Supplemental Materials (Optional)

Please ensure that your application form is complete.

Supplemental materials are welcome but not required. Possible supplemental materials include news articles that you have written or in which you were featured, relevant materials you have developed, or pictures/videos of a community activity in which you took part. You may submit these online or by email.

Submitting Your Application

• If you submit your narrative responses as a video, please upload your video to a video-sharing website (e.g. YouTube), ensure that the video is posted as "unlisted," and provide the link in your application.

All application materials must be submitted through the application portal or in one (1) email.

- ☐ If you are under the age of 18, your parent/guardian must provide consent for your application.
 - If you are applying via the online portal, please ensure your parent/guardian submits the online consent form they received in their email.
 - If you are applying by email, your parent/guardian must email <u>FEMA-Prepare@fema.dhs.gov</u> with their name, your name, and the following statement:

I confirm that I am the parent/guardian of the applicant listed above, and I consent to their application to FEMA's National Youth Preparedness Council (YPC). This consent includes their submission of the initial application and, if selected as semi-finalist, a video conference interview with FEMA headquarters and regional staff (including contractors).

FEMA will reach out to applicants if we do not receive the appropriate parent/guardian consent.

Submission Confirmation

FEMA will email a confirmation of receipt to each applicant upon receiving their submission. If you do not receive a confirmation email within three (3) business days, please re-send your application. Please let FEMA know if you encounter any problems with submitting your application by emailing FEMA-Prepare@fema.dhs.gov.

Please note that if you are under the age of 18, your application is not considered complete until we receive consent from your parent/guardian.
